

NTNU publishing agreement

for bachelor's and master's theses

This publishing agreement is valid for bachelor's and master's theses submitted through NTNU's chosen system for digital submission of papers, where the student submitting a bachelor's or master's thesis through the examination paper selects the option 'Yes, I agree to publication of the master's thesis'.

The student is authenticated through logging in to the system for digital submission of papers, and the system records person ID, time and which version of the publishing agreement is valid and thereby applicable at the time of submission. This information will be available in NTNU's institutional archive.

The publishing agreement, in all its versions, is archived in the NTNU archive such as the archive exists at any given time.

1 Permission to publish the thesis in electronic form

1.1 The author grants NTNU a free, non-exclusive right to make the author's bachelor's/master's thesis, hereafter referred to as the thesis, available in electronic form in the NTNU institutional archive, which entails publication on the Internet.

1.2 The author acknowledges and accepts the consequences of Internet publication. Among other things, such publication entails that external websites may publish links to the thesis. The thesis will be made searchable with metadata such as title, author, year of publication and abstract in various search engines on the Internet.

2 NTNU's obligations

2.1 NTNU will publish the thesis in unaltered form, as submitted to NTNU.

2.2 NTNU will protect the thesis against alteration by unauthorized persons/third parties, in accordance with such security guidelines as are current at NTNU at any given time.

2.3 NTNU is not granted rights of disposition to the thesis beyond what is explicitly stated in this agreement.

3 The author's obligations

3.1 The thesis submitted for publication must be identical to the one submitted for examination. The same submission process provides the option of submitting a redacted version, where any confidential content is redacted by the author.

3.2 The author asserts that he/she is the originator of the submitted thesis and has full rights of disposition to the thesis in its entirety. Should other parties have copyrights that prevent publication in electronic form through the NTNU institutional archive without explicit permission from such parties, it is the author's responsibility to obtain such permissions. The author guarantees that the thesis does not contain material that

may be in breach of Norwegian law or contains links or other connections to such material.

3.3 If the thesis is submitted by more than one person, each of the authors must make identical publishing agreements on submission to enable publication.

3.4 Should plans exist to publish the thesis, or parts thereof, in a journal or by a publishing house, the author guarantees that he/she has obtained in advance the necessary permissions from third parties. Upon entering into agreements with third parties (e.g. journals and publishing houses) over publishing rights to the thesis, the author must safeguard and protect NTNU's rights after the agreement.

3.5 Should NTNU be held liable for damages by a third party because the author has failed to comply with his/her obligations according to this agreement, the author is obliged to indemnify NTNU.

4 Printouts, etc.

4.1 NTNU has the right to publish the thesis on the Internet in such a way that printouts of the document can be made. NTNU also has the right to make single printouts and other copies of the thesis for internal use at NTNU.

5 Transfer of rights

5.1 NTNU shall not be able to transfer its rights and/or obligations according to this agreement to a third party unless the author's rights according to the agreement are protected in the transfer agreement.

6 Discontinuance of the agreement

6.1 NTNU has unlimited rights to discontinue publication of the thesis.

6.2 The author has the right to discontinue the agreement in writing. NTNU shall remove the thesis from its web pages as soon as possible, and no more than 6 months after receiving notification that the agreement has been discontinued.

7 Liability

7.1 NTNU bears no responsibility for the contents of the published thesis. NTNU is not liable for damages to the author's rights unless the damage can be attributed to intent or gross negligence on behalf of NTNU or person or persons representing NTNU.
